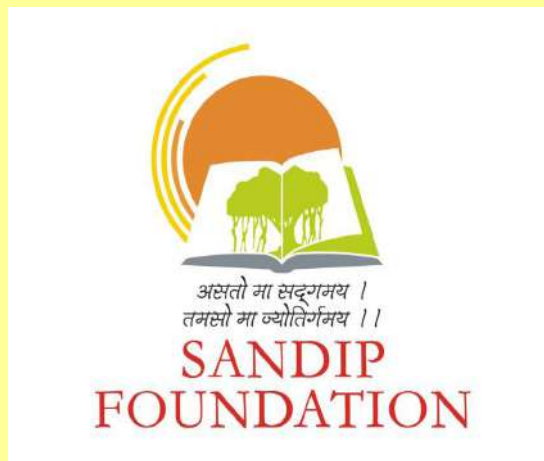

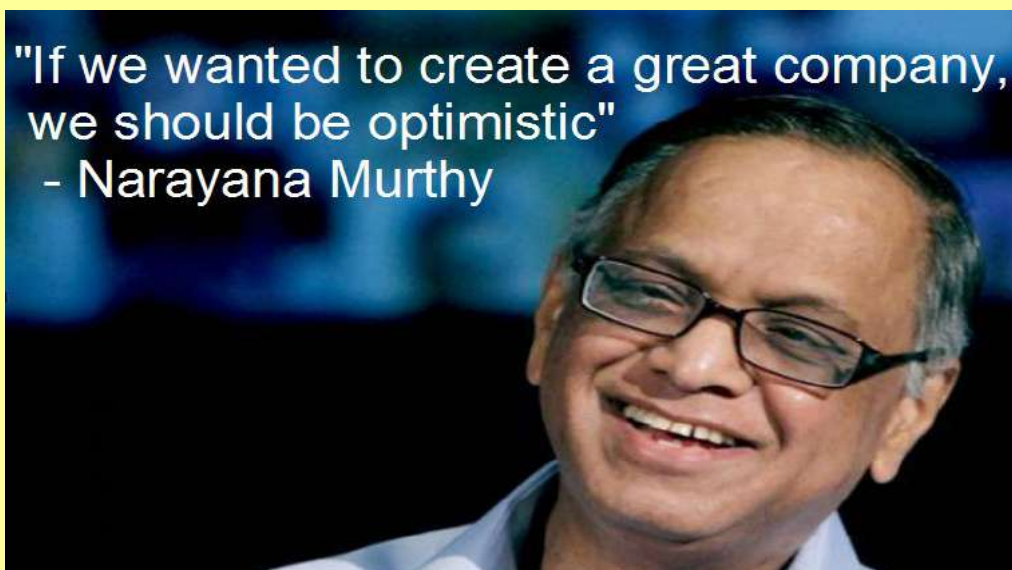


Shri Ganesh Festival: Worshipping God of Wisdom: (25th Aug 2017)
